
Subject to the following conditions:

1. Applicant/Operator shall comply with the rules/regulations prescribed by the board, failure to comply thereof and any of the conditions herein set forth shall be sufficient cause for the suspension or cancellation of the Authority herein granted.
2. The units/s shall be registered as fir HIRE with Land Transportation Office Agency of Balayan, Batangas in accordance with the prescribed rules and regulation/s.
3. Applicant/Operator shall secure a Mayor's Permit to operate business after registration with the LTO, per unit;
4. Within the authorized route, applicant shall charge the following fare rate per passenger per trip.
5. This Special Authority shall be valid for One(1) year from the date hereof, shall constitute as franchise certificate giving operator the privilege to operate unit/s herein prescribed for hire or compensation;
6. Without previous authority from the Board Operator shall not increase transfer drop and substitute units as well suspend or abandon the service herein authorized otherwise the authority herein granted shall be declared forfeited or cancelled;
7. Applicant/Operator shall pay the Supervision Board Fee in the amount of P400.00 on or before September 30 for every year subject to penalty and sub charge in case of late payments;
8. Protect this Document. Its lose or destruction may affect your legal rights to operate service, any addition, alteration, or deletion not otherwise authorized will invalidate this document .
